## MANAGEMENT COMMENTARY

In February 2021, the NOVA Green Energy fund appreciated by 0.29%. The appreciation from the beginning of the year is thus 0.79%. The production of photovoltaic power plants in recent months has been below the value of the energy audit, specifically in January by 2% lower. Biogas stations and a biomass heating plant in Krnče are at the expected average.

The new photovoltaic project in Csabrendek, Hungary, with an output of 28.5 MW is fully under the control of the fund. Financing is in the phase of submitting of the binding offer and preparation of the loan documentation. The construction site was handed over to the general contractor, deliveries of panels were completed, earthworks, fencing construction, etc. are in progress.

In Slovakia, we have prepared and sent an application for the connection of 500 kW photovoltaics to the roof of the Industrial Park in Trenčín and one other industrial enterprise. The building of the Orlice Hradec Králové shopping center applied for a subsidy from the OPPIK of the Ministry of Industry and Trade for the construction of rooftop photovoltaics with an output of 500 kW and a battery storage facility and has been declined. For other buildings of the sister real estate fund, pre - registration calls were submitted to the Modernization Fund, which was launched in 2021.

The projects of the two biomass heating plants, which receivables form the assets of the sub-fund, are operating as expected. After the crystallization of the situation with Arca, we will communicate with the bank about obtaining approval to acquire both energy sources into the subfund's assets, or to repay our loans. We will inform you about the next steps.


